Purebred Horses – Imports include a copy of the ASPC Registration Certificate. Local horses provide copies of the ASPC Registration Certificate of both purebred parents.
Part bred Horses – include a copy of the ASPC Registration Form of the purebred relative(s) and documented proof in the form of an official registration certificate with an approved Registry showing the pedigree of the horse back to the purebred relative. If the Registrar or Committee is not satisfied with the validity of the proof supplied DNA tests proving lineage back to the ASPC registered parent will be required.
All Horses – include vet certificates and other supporting material in addition to the proof of pedigree documentation. DNA testing by Genome as part of the registration process will be used to parent verify the horse applying for registration so hair samples will be required from both Sire and Dam.
